#### PREFACE

This is the forty-ninth volume in the series 'Annotated Leading Cases of International Criminal Tribunals' and contains the most important decisions of the Special Tribunal for Lebanon (STL) handed down in the period from 2009 up to 1 January 2014. It is the very first volume in the series containing decisions of the STL. Given the ongoing jurisprudential output of that institution, further volumes on STL case law will be published in the series in the coming years.

This volume is in its approach and structure similar to previous volumes. Thus, the book contains the full text of all the annotated decisions and judgements, including any separate, concurring and dissenting opinions, as well as annexes to the decisions. As with previous volumes, the Editors have ensured that the decisions are fully identical to the *written* original text, as issued by the STL Press and Information Office, and which bears the signatures of the Judges, as only these can be considered as authoritative versions. In the course of our editorial work on this and previous volumes, we have occasionally discovered inconsistencies between the written original version of the decision and any available internet versions.

Although we are only able to include the full text of the decisions by reducing their original format, we wanted the reader to be able to identify the page number of the original text, which is placed in brackets [].

We are very pleased that a number of distinguished international criminal law scholars were prepared to write interesting and stimulating commentaries regarding these decisions, and believe that their contributions will add to the breadth of knowledge and understanding about the work of the STL.

A few words regarding the selection of decisions in the ALC volumes are appropriate given the fact that we have decided to change the policy concerning the publication of judgements. In previous volumes, we selected all final judgements, rendered by both the Trial Chamber as well as by the Appeals Chamber in the same case. In view of the fact that more and more judgements deal with established case law, and in light of the space all the judgements cover in the series, we have decided no longer to select Trial Chamber judgements in cases in which there is already an existing Appeals Chamber judgement. The commentator to the latter judgement is invited to include a comparison of the Trial and Appeals Chamber judgements in his or her contribution. In doing so, we expect to be able to focus more on the key issues that are at stake in the case at hand. In addition, we expect to be able to publish the volumes sooner following the handing down of the relevant Appeals Chamber judgement.

With regard to other decisions, the existing policy will be maintained. This means that, additionally, we will continue to publish decisions taken at any stage of the proceedings that are important for other reasons: because they deal with a specific legal question, because they are representative of a specific type of decision, or because they enter new legal waters. As a result, we may not publish decisions in which issues have been decided in a way similar or identical to a decision that has already been selected.

The decisions annotated in this volume are presented in various parts and under different headings.

Part I, 'Preliminary matters', includes four different topical themes. The first relates to pre-trial detention dating from the early days of the STL. The second group of decisions concerns deferral and cooperation issues. The legality of the Tribunal was the theme of two decisions and, last but not least, the applicable law of the STL is discussed

Part II, 'Procedural Matters' forms the larger part of this volume, as the STL in the relevant period did not yet reach a stage in which judgements are rendered. Various topics give evidence of the leading themes of the first years of the STL: indictments, the participation of victims, decisions on the disclosure in the matter of El Sayed, other disclosure decisions not related to that case, various procedural matters, and decisions on *in absentia* proceedings, witnesses, impartiality and duty counsel.

Once again, we gratefully acknowledge the assistance of many people without whom we could not have completed this volume.
