She was a visiting researcher at UNIDROIT (Rome) in 2000, 2002 and 2016.

### **Joel Samuelsson (Sweden)**

Joel Samuelsson, Dr. iur., is Professor of Private Law at the Faculty of Law of Uppsala University. He specialises in the methods of interpretation of commercial

contracts but his research and teaching interests also include general issues in the law of obligations, European private law, jurisprudence and legal hermeneutics.

**Martin Schmidt-Kessel (Germany)**

Professor Dr iur. Martin Schmidt-Kessel studied law in Freiburg im Breisgau, Munich and Cologne and again Freiburg where he was awarded his doctorate in 2001 and his habilitation in 2003. From 2004 to 2010, he worked as Full Professor for Comparative Law at the European Legal Studies Institute at the University of Osnabrück. Since 2010, he has been a Full Professor of German and European Consumer Law, Private Law and Comparative Law and Director of the Centre for Consumer Law at the University of Bayreuth. In 2014, he became Associate Member to the International Academy of Comparative Law. Since 2015, he has worked as speaker of the Joint Doctorate Verona-Bayreuth in European Legal Studies and in 2017 he became a member of the PhD Committee in European and International Legal Sciences within the PhD School of Law and Economics of the University of Verona.

**Gema Tomás (Spain)**

Gema Tomás holds a PhD in law from the University of Deusto (1999) and has been a Full Professor of Civil Law since 2015. She is the organiser of a number of international and domestic conferences, author of many papers and author or editor of several books. During the negotiations for the Croatian accession to the EU, she was appointed the Head of the Negotiating Team Working Group for Consumer Protection and

Health. She is a long-term active member of the International Law Association and since 2006 she has been the President of the Croatian Comparative Law Association.
