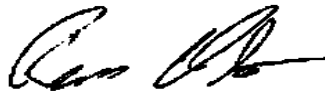

There's a dramatic twist in the death of JFK Jr.!

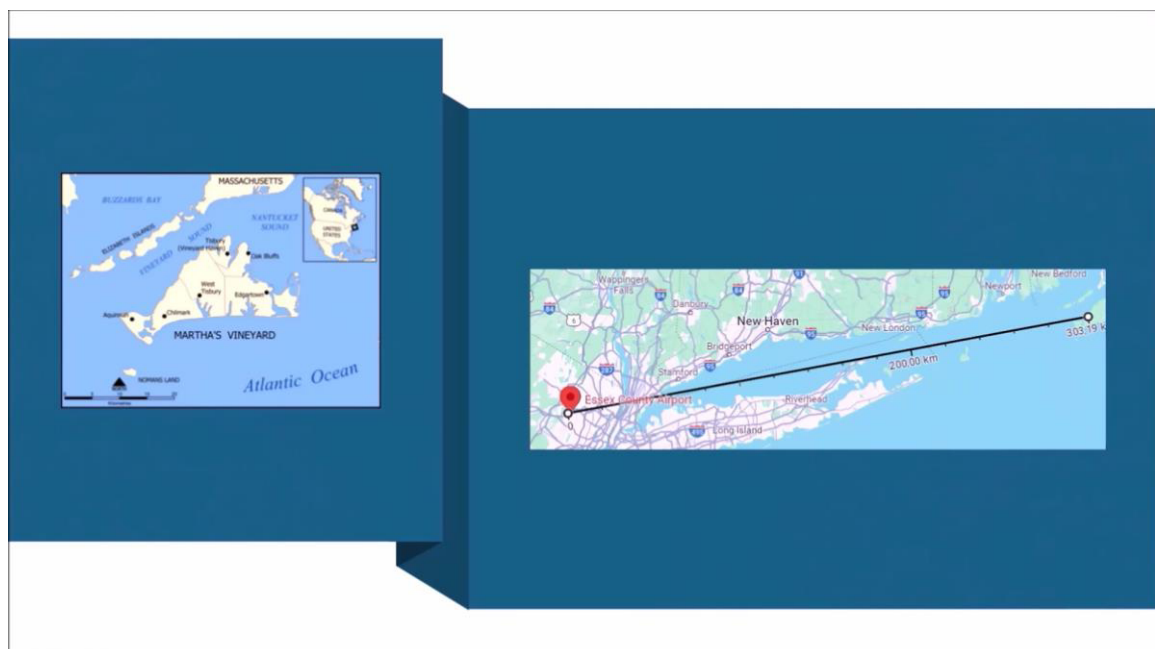
According to the U.S. Coast Guard accident report, John Fitzgerald Kennedy Jr. took off from Essex

JFK Jr.'s urn, those of his wife, Carolyn, and her sister, Lauren, were interred at sea **on July 22, 1999,** after a ceremony aboard the destroyer **USS Briscoe** between Martha's Vineyard and Hyannis Port.



The aircraft involved in the accident is said to have been a **PIPER PA-32R-301 SARATOGA II** with the registration number: **N9253N!**
