INTRODUCTION

Readers not familiar with the subject of extraterrestrial activity will no doubt be amazed to hear that this is now an extensive field of information, irrespective of what the media, science and education has taught them. It is important to realise that key areas of this knowledge have had the highest secrecy classification over any other government activity (since the 1940s); even to the point of the government simulating UFO crafts so that the public will think all UFOs are military crafts. Moreover, the material in this book dwarfs in content the highest government material on the extraterrestrial phenomenon (it therefore must come under attack or discredit).

A shocking reality shift will be expected for the reader, which may occur now, or when it eventually abruptly unfolds with proof within mainstream knowledge and education. Our educational systems are set up to produce humans with a context-dependent mind (lacking in creativity, imagination, intuition, or original thinking). Throughout one's life, patterns/-recordings of every detail of existence form rigid contexts (like energy templates/moulds—compare 'moulding the mind'). Thus a complex back-ground structure of reality forms within the unconsciousness that the conscious mind continuously references unknowingly. When confronted with anything in conflict with this established secure foundation there can be a severe reaction at the disturbing conflict, causing insecurity, fear, hostility, or just sheer disbelief. It is extremely difficult to accept the new information, or even as a possibility.

Some people (mainly within the New-Age movement) will designate these extraterrestrial revelations as 'fear-based.' This objection originated with the idea that whatever one focussed one's attention on is given more power (over one). This is true in the narrow context, but in the wider view the reverse applies;

that a severely impaired system needs direct attention, an understanding of how it works, and the application of remedies (also: 'Know Thy Enemy', applies). At the very least, if the population became merely awakened to what was happening behind the scenes on this planet it would reverse any downward trend, and restoration would be facilitated.

We can present an analogy here that will help to buffer the reality shift to accepting the common presence of ETs throughout history. Keep in mind what the analogy is for; to shift the current world-wide programmed condition that only humans exist on Earth and there is little or no evidence of visitors from other planets.

Imagine that only England exists on Earth (or any other reader's country) and there are apparently only English people, and that this has always been the case. Then one day someone reveals that there are foreigners present. Imagine further that these foreigners were born here and few are aware that they were not English.

The reader can now make the comparison with the reality that only humans exist on Earth, but then consider that many so-called humans are, or were originally, ETs but came in at birth and most have forgotten who they are. They are ET souls that have taken on the human DNA, which is a template like a mould humanising the ET into being a human. The more the alien reincarnates into human bodies, the more the DNA and environmental experience humanises it. However, it is important to recognise that this ET still has the imprint of its own race DNA and all memories and experiences are still intact.

Basic consciousness underlying all matter, body, brain, mind, is an Absolute; it is the same for all natural entities, whether alien, human, dog, the Earth, etc.; even an atom has a Tiny speck of Absolute/consciousness/intelligence. Thus there is nothing strange about an ET consciousness being reformatted (by the human DNA and Earth life) to be a human and not even know it. However, there has to be a degree of compatibility between the human DNA and the incoming ET's DNA. In the case of the Illuminati, they utilised a specially assembled DNA (see Chapter 8).

To pursue the analogy further, the ETs can be divided into two groups: benevolent and non-benevolent. The benevolent

ones tend to wake up to who they are; they are usually on mission to help the planet ('star seeds', or 'indigos'). The non-benevolent are mainly the Illuminati but most don't wake up to who they are; moreover, they are the puppets for their own race, who pull the strings when specific programmes are initiated. Note that some of the Illuminati are sufficiently humanised to side with humans against their own race's exploitative agendas.

Almost everyone has some degree of interest or curiosity in one or more of the many enigmas or unexplained phenomena, such as Stonehenge, the Bermuda Triangle, the Moon, the dinosaurs, crop circles, etc. Nevertheless many readers must puzzle over why unusual, non-conventional explanations are suppressed or hushed up. The answers will become very clear as the reader is familiarised with the extraordinary events taking place within covert politics and in the local dimensions of this planet, and the reasons for the need for 'authorities' to perpetuate an uninformed public.

All sources of public education, whether science, religion, schooling, media, are infiltrated to programme the civilisation with reality structures very different from the actual state of affairs. Most readers will be shocked and even outraged with the implications that our history, evolution and present circumstances could be so different from what they have been led to believe. For example, even the subject of dimensional portals (a frequent reference in this book), which should be elementary physics, will be denied by the educated—in spite of the fact we have in physics established the existence of the wormhole. One may find that this is why higher-dimensional geometry is not taught in schools, as this would set up a mental context for a huge expansion of knowledge. The subject of portals was common knowledge a few thousand years ago. Even the atom has a portal at its centre, but one is not allowed to deduce that energy could be coming through that portal into 3D, otherwise a person may have the cognition that the energy may be perpetual (when we 'know' energy is very scarce and expensive!).

Thus each chapter in this book deals with a different unresolved question of historical, scientific, religious significance, including some popular enigmas, such as the purpose of Stonehenge, or what the 'Bermuda Triangle' is all about, etc.¹ In this introduction, we merely wish to prepare readers for what

may appear to be the most outrageous information that they have ever encountered. Contrary to the general attitude of the orthodox and conventional thinking mind, all these unanswered problems are resolved by the very answers that people are trained not to believe in. It will take some time before people realise, or can admit, the extent of the deception they have been living under; even false realities that they have been programmed to create. Let us give a couple of analogies to precondition the reader to the magnitude of what is happening behind the scenes on planet Earth as we present the bigger picture.

Imagine a room in a house, say, the kitchen, one that is reasonably busy, and that a group of ants have settled in one corner. We appreciate here the extent of the obliviousness of the ants of what is going on around them; a dog or a child may come close, within inches; numerous kitchen activities and functions are frequent, such as washing or cooking, which would be concepts not within the consciousness of the ants, let alone intellectual conversation. There are also further rooms in the house with associated activities, incomprehensible to the ants. There are further houses, cities, a government, countries, planets, etc. The point has been made: ants in this analogy are of course humans.

We are unaware of the vast and multitudinous activities of life going on all around us. The public haven't been educated to understand that consciousness functions like the television antenna on the roof, which selects wavebands according to the channels chosen. Similarly our consciousness is tuned to the spectrum of frequencies (or waveband) corresponding to this 3D reality only.

Minds are being specifically manipulated to exclude attributes of consciousness that can recognise and acquire truth beyond the objective methodology of science with its inbuilt limitations.² Consciousness has been brilliantly formatted (moulded) to create within itself contexts (powerful contextual structures that are not part of the design of the Divine Cosmos, that is, not in alignment with universal harmony).

Let us explain this unawareness with another analogy. Consider a viewpoint above the ocean. We only perceive the surface. But we know it has depth with activities and causation

below this surface. Imagine now in this analogy the surface of the ocean is our external 3D world. The programmed knowledge today is that the surface is the ocean. Similarly our view of the universe and what science detects is only the surface (of the universe). We do not see the inner or higher space (the depth of the 'ocean').³

On the subject of extraterrestrials, what little is left from a rewritten history has been turned into mythology—a perfect cover-up and deception. However, readers may continue to question or simply ponder why there is so much claimed extraterrestrial activity on our planet with no 'reliable' evidence, and why would these aliens be so interested in humans or, in particular, this planet, if they are so much more advanced. The answer is firstly to question the word 'advanced'. Virtually all extraterrestrials that interact with our government, or have Earth agendas at 'ground level', are not advanced spiritually. They may have super-level intellectual ability, powerful psychic abilities and are above corporeal dependence, such as a physical body. But after years of violations of the harmonic laws of the cosmos, that is, abuse of nature and creation and transgression of the rights of other life forms, they consequently have reversals in their energy systems; for example, DNA (note that the DNA for any life form extends beyond the physical/biological strands).⁴ They may have much more DNA activated than humans but polarity reversals have cut off their higher source. In terms of simple physics, the higher frequencies resonate from higher aspects to lower aspects but in their case the lower frequencies go out of resonance/phase.

A sufficiently harmful act will put a frequency pattern out of step with its higher source and, further, may cause the reversal condition—the subatomic polarity of particles go out of phase with their counterpart pre-matter particles. The reversal (negative though it is) protects the lower fragmented, less powerful energies from higher, overriding and forced corrective effects, and subsequent destruction of the lower patterns (our physical level); thus giving the lower level opportunity to restore itself.

In this condition, in order to survive, these beings will have to be parasitic of other races to retain a coherent conscious identity and endeavour to live indefinitely. Note that we humans

are parasitic at the physical level (life on this planet feeds off other life).

The malfunction (the reversal) within the DNA of 'advanced' ETs gives rise to the so-called 'Light forces against the Dark forces'. The 'Dark forces' are those cut off from their basic source, the 'Light', and therefore must be parasitic of, for example, 'soul' energies (hence the expression stealing one's soul).

We shall encounter this theme in the chapters to follow and this brief description here will enable the reader to understand why such enormous effort is made and patience exercised by these aliens for thousands of years to secure a future for them that can be extended for millions of years.

Further queries may arise regarding the improbability of so much alien activity. For instance, why isn't the evidence more obvious; surely SETI after all these years would have some smattering of evidence? Or, how could these alien activities be going on without our knowledge of them?

The answers to these objections become clearer as one acquires more familiarity with the subject, which this book provides. More specific evidence is obscured within many aspects of existence: mythology; an understanding of the factors determining the detectable and visible ranges of matter; a rewritten history; etc.

It would be helpful if the reader not only had some familiarity with the subject of extraterrestrials and some acceptance of covert (underlying) politics, that is, Illuminati activity, but also exo-politics,* otherwise much of the information won't make much sense (such as the connection between political activities and alien agendas). Without this familiarity, the advice is to take the neutral state of mind: neither believing nor disbelieving. 'Disbelieving' will place a block between the conscious and unconscious mind, adversely affecting learning in this same area in, say, the future. 'Not believing' is quite different; it is the neutral state, open-minded and ready to receive answers (which the unconscious will now more readily permit). [* This refers to ET politics: an influence usually underlying covert politics.]

People may joke about the 'end of world' prophesies, but some are true ('prophesies' give us an opportunity to change the condition if not desired). One might say this book is a major

training ground to accustom the public to the commonplace presence of ETs in our midst. We have been so successfully 'dumbed-down' by education, the media, science and religion with, in particular, advanced and subtle covert-mind control.

Thus on Earth we have a mixture of humans, that is, many partial hybrids containing some ET genes and subsequently easily infiltrated. We have alien consciousness (souls) in human bodies, 'humanised' by the template-formatting aspects of our DNA. These are the Illuminati. However, the latter are not generally aware of who they are. These are sometimes called 'sleepers' and can be easily motivated externally to do the bidding of the main source, the off-planet races. Even technologies—certainly the HAARP system (see Chapter 9)—are inspired by ETs to assist them in their plans. The 'human' Illuminati may have their own agenda but generally this covert political level fits in with the exo-political level—see the complexities of the 9/11 event. The public are confronted with several levels of causation, usually conforming to a pattern: public-level politics, utilising falsehoods, false flags, etc. and underlying that, covert politics, revealing the Illuminati mind level, and finally exo-politics, the principal source.

One of the main effects throughout history on the human race has been from the fact that we have been in the midst of a battlefield not of our own making, with clever interwoven conflicts involving hiding the true causes. The meaning of this will become clear throughout the chapters.

Possibly the main difficulty the reader may have, as we have already indicated above, is regarding why all this alien activity is not more 'visible'. This is an elementary objection and area of knowledge, yet physics is discouraged from evaluating it, in more than one sense. The fourth-dimensional astral plane is invisible to us but at that level the structures are quite solid (just as we can't hear sound above our limited frequency range, yet we know that dogs can hear above this range). Scientific instruments either can't detect or respond to those higher frequencies, or where interaction does occur in the observation process, the scientific set-up 'unwittingly' quantum reduces, that is, collapses the wave function to our 'ground-floor' level of existence.⁵

Another objection that the reader may have is regarding the destructive behaviour of authorities/Illuminati, etc., such as how could any intelligent person actively support the poisoning of the air we breathe and the water we drink. There will be a surface level of information for the relatively uninformed; a programme in which people blindly accept what is being done and simply believe in the benefits (which the programme claims). The answers to these questions will become clear as we read through the book, such as why are there so many conflicting viewpoints on the subject of ET activity? Why are there cover-ups, government and military secrecy, etc? Why is our civilisation having so much difficulty surviving peacefully and healthily on this planet?

This type of material in this book, with its many threats to the survival of a civilisation given here, must be known if solutions are to be found. The real test is whether solutions are also included. Any recognised negative event indicates what type of solution is required. It may simply be necessary to use a technique to protect oneself, but if one didn't know it was required then one is worse off. Or if one is, say, imprisoned metaphorically (or literally), it is better to know it. We live in a world of extreme disharmony with endless factors of disintegration. Such a state requires knowledge from advanced sciences to explain the failures, since science deals with how things work. Thus knowledge of how energy works (the domain of physics) could potentially solve all problems. In contrast, a civilisation that has evolved harmonically can successfully and safely act more spontaneously, relying on subjective perceptions and realisations; and their need to know the objective mechanics of life would be less.

The more significant pieces of extraterrestrial material in this book are just a sample of information and must be taken in the much larger context of an extensive source of highly technical off-planet material, referred to as Keylontic Science, transmitted by A. Deane from the 'Guardians' (over the past 15 years). Earth 'Speakers' who transmit this information were prophesied in the Seth material channelled in the early 1970s to bring in knowledge at times of crisis, such as today. But the main sources in this book are not from New-Age channelling.

Before studying the following chapters it might be helpful to the reader (and of interest to the more technical) to recognise the notation being used for dimensions. In 3D we have 1D, 2D, 3D expressing the quantitative orthogonal at right angles to one another, where 1D, 2D, 3D are identical except that they are at 90 degrees to one another. When we write D1, D2, D3 (the 'D' first) we also express the qualitative aspect, that is, the frequency spectra. Now, D1, D2, D3 are different, qualitatively, with increasing frequencies from D1 to D3. This applies all the way up the dimensional gradient.

CHAPTER 1

The Missile that Went Awry

The Sun had dipped behind the high-rise buildings as I parked the car outside my home. Everyone appeared to be staring up at the sky with great interest. As I stepped out of the vehicle, a young boy caught my attention: 'Is it a UFO?' he said.

The sun's rays were reflecting from a neat looking cumulus cloud high up, much like the effects of a war-time search light. There was clearly no visible UFO but it was a spectacular sight to behold. This event occurred about 30 years ago while living in the United States, Los Angeles.

Surrounding the cloud was a kaleidoscopic display of brilliant colours: vermilion red, orange, yellow, lime green, violet, zigzagging around the cloud. This extraordinary sight had no parallel and thus there was nothing of a conventional nature to satisfactorily explain it. In particular, it was the combination of the spectacular vapour trails of vivid colour and the white light glowing from the cumulus cloud that added to the confusion.

To assist further understanding here we shall digress into two significant pieces of information. Firstly, sightings of these smoothly formed clouds are not so uncommon, but apparently some really do have a spacecraft obscured within. A craft may teleport into our atmosphere, in particular, from a region of different temperature, causing condensation around the craft and the appearance of the cumulus cloud. It then may teleport out of our third dimension, leaving a water-vapour copy of the space-craft.

Secondly, the U. S. Military in the early days of UFO visitations discovered that if they attacked some alien spacecraft

using a heat missile, although the missile could not penetrate the craft's field, it would nevertheless interfere with the craft's antigravitational field. This caused the necessity for the crew of the craft to land. The government's secret military would then attempt to apprehend them.

That same day of the mysterious sky display over Los Angeles a radio announcement was made in the evening. Clearly everyone expected that the government would have an answer. But amazingly and understandably they had to reveal what it actually was, at least the after affects, since nothing else would give a satisfactory answer. That is, they felt they had to state at least half of the truth.

The news announcement was very brief stating that Vandenberg Air Force base had sent up a 'rocket' and that it had gone wrong! What were they doing sending up a rocket over Los Angeles, one would ask? What about the potential dangers to human life? And that was it; nothing else.

At that time the author was researching all material, mainly channelled, from extraterrestrial transmissions. After a few days, a regular radical publication transmitted comments on this incident from an ET space-fleet commander, who explained it was one of their crafts (within the cumulus cloud) and indeed the military, true to form, had in fact sent up a heat missile in an attempt to bring down the craft. Further details were that initially the military were preparing to launch a rocket which had in fact a nuclear warhead. (Hard to believe, but presumably it was directed over the ocean.)

The ETs, being in a constant state of vigilance regarding any reckless military and government behaviour, not just potential attacks on them, but the dangers inherent in nuclear weapons and war strategies, sent a warning to the appropriate military personnel that the rocket would be disabled if it was launched.

Communication is not uncommon between the military and aliens. Needless to say, the government ignored the warning and were determined to execute their programme. Amazingly according to this ET transmission they prepared another rocket, which was normally unarmed, except that this was deceptively armed. However, the ETs were fully aware of the ruse and sent another warning that the rocket launch would be stopped. The arrogance and hostility of the military took over and after

successfully locating the spacecraft (over Los Angeles; in fact, approximately above Echo Park), they sent up the heat missile.

These ETs, however, of the so-called (and well-known) Ashtar Command, were in full control.¹ They deliberately toyed with the missile, creating the exotic streaks of colour, then annihilated it, leaving no debris to harm the population. And another ET event was concealed from the public.

It is interesting to note that these extraterrestrial transmissions have also mentioned that although the American secret military establishment had orders to shoot down UFOs, the Russian government and military were quite friendly. (Note: there are many factions of aliens—some groups liaised with the secret-government; see chapter on MJ-12.)

CHAPTER 2

Bermuda Triangle

One of the most dramatised mysteries in history must be the phenomenon associated with the so-called Bermuda Triangle. It has been fictionalised, serialised and analysed exhaustively, giving rise to a whole range of explanations from extreme orthodoxy to paranormal and extraterrestrial origins. The Bermuda Triangle is in the region northwest of the Atlantic ocean, bounded by Florida, San Juan, Puerto Rico, and Bermuda.

It is generally rumoured that few have lived through a full experience of the effects of the Triangle to tell of their experience. In fact this lack of such incidence, of ones who might have witnessed paranormal effects, is taken as evidence contrary to anything abnormal happening at all—that is, few if any have lived to tell of their experience. However, probably one of the best of such encounters is described in the article ‘Close Encounters in the Bermuda Triangle’ by Trish and Rob MacGregor.¹ They refer to the ‘official silence surrounding a secret US Navy base in the Bahamas, which is linked to UFO activity, sometimes referred to as underwater Area 51’. We shall see shortly the real reasons for such intense official investigations and secrecy.

Many people have some knowledge of the history of the Bermuda mystery in which ships and aeroplanes have apparently disappeared. Possibly the most mysterious on record of missing aircraft was in December, 1945. Avenger Bombers that were on training flight disappeared, leaving no traces, no wreckage found, etc. The many and diverse theories range from no mystery at all—that the statistics for loss of boats and aircraft is not any more significant than in many other regions of

the planet—to scientific theories, such as bubbles erupting from frozen methane on the sea bed, to increasingly popular vortex and wormhole theories and their magnetic fields, causing aircraft instrument anomalies.

The methane gas theory is probably the most popular scientific explanation. Explosions of bubbles directed upwards (demonstrated in models) are said to be capable of reducing the buoyancy of ships sufficient to sink them, and that the bubbles even rise well above the surface of the ocean and affect aircraft, pulling them down.

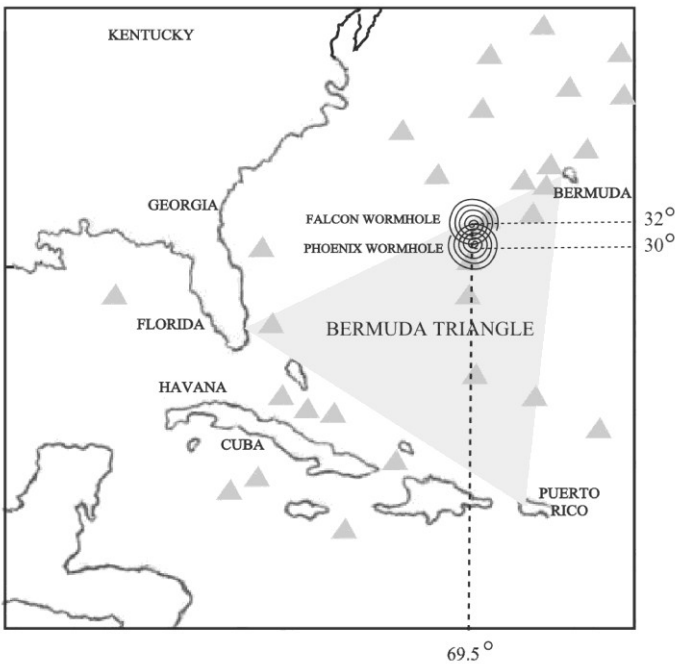


FIGURE 1: Large triangle depicts most commonly selected region for disasters. Small triangles are the approximate locations of disasters as taken from Charles Berlitz's book.

The effects of violent storms is another more obvious favourite amongst the explanations: white squalls, intense thunderstorms, deep currents from the Gulf stream. Navigation during such weather disturbances can be jeopardised by

unpredictable effects in the manoeuvrability of aircraft, causing pilot errors.

It is not so much a question of finding explanations for the phenomena, which are abundant, as it is a matter of evaluating any one thoroughly to a definite conclusion of adequacy of data or certainty. That is, taking into account all information, bizarre or otherwise, and either reducing the evidence to insignificance or expanding it to a degree of certainty.

The Bermuda Triangle phenomenon is not likely to be effectively evaluated for some time officially, due to focussing on the conventional and orthodox approach. The public, and seemingly the majority of scientists, have no idea or wish to believe that reality goes well beyond the limitations of the scientific method. Science is literally in its infancy. Arrogance is an initial problem, but underlying that are covert politics and also exo-politics, which we shall not pursue here (in the political sense).

Modern science has no idea of the multiverse structure of universes—a holographic fractal system consisting of a complex matrix of vortices. The vortex provides the energy circulation, and is the natural link between dimensions, degrees of order, and changes in frequency bands. Science is only detecting the surface effects. There are many vortices beginning in our 3D 'surface' and tunnelling within, that is, into the inner space. This is the same general geometry as wormholes and blackholes.

Readers who have little comprehension and awareness of the fact that there is now a vast amount of information on extraterrestrials from reliable sources, will not be able to make any sense of the Bermuda Triangle explanations. The minds of the public have been so thoroughly programmed—an actual build-up of frequency-pattern structures (which act like a mould to consciousness)—it is very difficult to make sense of material which may even subdue science fiction. Those who are awakened to the ET scene will find academic discussions, say, on television documentaries too naive to tolerate. These sceptical programmes are also destructive to the minds of people who need to know the truth, such as the history of ETs on this planet, which has been re-written, utilising ingeniously, mythology, to ensure exclusion of an education in ETs and UFOs, and many other related subjects and events.

Take, for example, SETI (Search for Extraterrestrial Intelligence). Not meaning to be disrespectful to the scientific members but it can only be arrogance that prevents them from confronting or studying the huge amount of ET material abundant on this planet. In effect, SETI is subversively being used to dumb down knowledge of the commonplace presence of ETs and, in particular, their role in our 'evolution' (which is, in fact, more of a rehabilitation). Let us give a simple analogy and then return to the Bermuda Triangle explanation.

Imagine an ocean with 'flat' fish (2D) swimming on the surface and confined to this surface, which is their dimension (like the flatland stories). Compare this with our civilisation in 3D. They send out signals, waves of information along the surface for miles, hoping that there will some day be a response from corresponding alien fish. But it never seems to happen; there clearly is so much scarcity. The big joke on this 'civilisation' is that right there under their 'feet', in the depths of the ocean, the water is teeming with life; 'alien' fish. They occasionally come to the surface, causing maybe just a ripple (an 'unidentified object').

Similarly the universe is teeming with life, in particular, within inner-space dimensions. It is incredibly easy to programme the human mind only to believe in and focus within a given limited context. When this is repeated enough to many people the power of the unconscious is such that it creates that reality (of limitations). Science is notorious for programming such limitations into the public mind—most laws of physics are relative, they need periodic updating.² As we shall see later in this book, earthman, in particular, the government, have been in communication with the extraterrestrials since well before 1950—see Chapter 3. As an addition to the above flat-fish ocean analogy, one might visualise other 'ocean surfaces' below the actual one, representing other universes, and then we have a simple picture of the whirlpool (vortex) that spins down from the surface, linking together different universe layers (surfaces). Ideally one should have an upward vortex from the layer below meeting the one going down. This is a little introduction to the vortex.

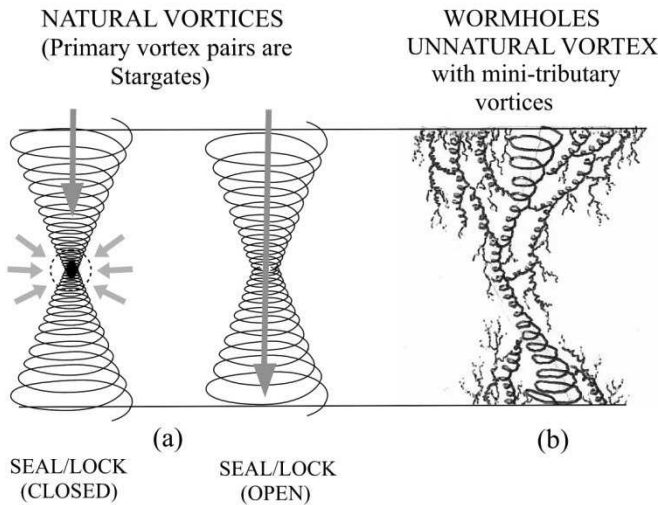


FIGURE 2: Comparison between natural portals (part of original universal design), and unnatural wormholes.

An electromagnetic vortex network system interlinks and integrates all aspects of the multiverse, providing fundamental

circulation or currents of energy, creating all facets of reality. Gravity is an aspect of the electromagnetic vortex; the latter holds together the universe, not gravity (as science believes).³ These vortices are natural constructs in a holographic fractal design.⁴ These high-frequency electromagnetic vortices are not detectable by current science. However, in addition to these ordered vortex networks, there are wormhole vortices that are unnatural. That is, they are rips in space-time created by technologically advanced ETs (see Figure 2). We can now return to the Bermuda Triangle.

There are actually two major unnatural wormholes in the Triangle. These have been referred to as technological abuses from Atlantean times, and are artificially created transdimensional geophysical anomalies. One is on leyline-3 at 32 degrees north latitude, 69.5 degrees west longitude, and the other on leyline 4/10 at 30 degrees north latitude, 69.5 degrees west longitude. Both are on axiatonal line 7, 69.5 degrees West (which gives a 4D inner-space direction) as described in transmissions from off-planet sources.⁵ See Figure 1.

As we shall see later in the book, earthman, in particular the government, has been in communication with off-planet visitors since before 1950; see Chapter MJ-12. In actual fact the earliest contacts with governments were apparently before 1920. Anyone who thinks this is fiction or a hoax is simply being duped (programmed) by the media and covert government agents to conceal related secret agendas.

The United States authorities such as the U.S. Navy do not officially recognise the triangle. There can be numerous reasons for this, ranging from 1) groups who do not believe that there is any significance to the numbers of accidents, 2) to those who do know what is going on but don't wish to reveal this as it may affect the business and commercial gains from cruise lines and air lines, 3) to government cover-ups that hide information of ET activities, in particular, MJ-12 meetings and negotiations with aliens (see Chapter 3).

Ironically these regular ET visitors do not have benevolent plans for the human race and would not divulge the real truths behind their activities, such as that relevant to the Bermuda Triangle and the purpose of the wormholes, or even where they lead.

There are going to be some uneasy moments, even serious shocks for many people when there is a full disclosure, notably to the programmed educated sceptical scholar. In this chapter we shall merely introduce these wormholes and where they lead and then as the reader becomes more accustomed to accepting ET intervention we shall continue with the subject of the role these vortices play.

In Figure 1 we see the main region of accidents delineated by the Triangle. This size and position of the triangle is said to be the most common to investigators and writers—each side of the triangle is about 1000 miles long. However, there are other opinions on the triangle position which best fit the actual distribution of disaster incidents. The small triangles in the figure give the most significant and most investigated locations of disasters and were taken from Charles Berlitz's book.⁶

An inspection of the large triangle and the small ones reveals a poor fit. The triangle does not match well the distribution of the selected common accidents. Yet more importantly the distribution given by Berlitz fits well over the

regions of the two wormhole locations. One may wonder how far the wormhole extends its influence on ships and boats.

Any effect that extends beyond the wormhole geometry will be due to tributary wormholes, even countless mini-wormholes (compare physics' mini-black and mini-white holes). This is now called a wormhole matrix. We shall see later in the chapters that these matrices are extended, sometimes to link to other systems and expand the network.

The names of these two wormholes are the Phoenix wormhole, created first by the Anunnaki, and the competing Falcon wormhole, created by the Anunnaki's sworn enemy, the Drakonians. Both wormholes were installed in the space-time structure about 12,000 years ago.⁷

But where do the wormholes lead? What happens when one falls prey to these structural anomalies of space-time? This will become clear as we proceed through the subsequent chapters.

CHAPTER 3

Majestic Twelve

This top secret operation, MJ-12, which consisted of government personnel, high-ranking military personnel and scientists, was established in 1952 by President Eisenhower. Prior to that, aliens had been in contact with Earth governments since before 1920. In 1947 President Truman approved the National Security Council, NSC-4, to handle intelligence activity related to the alien agenda. Later, by 1952, after increasing degrees of security and secrecy were approved, Truman had created the top secret National Security Agency.

As a result of discussions between Eisenhower and Nelson Rockefeller, MJ-12 was born. Its initial purpose was to take exclusive control over all aspects of crashed UFOs and alien occupants, dead or alive, in particular and initially the Roswell UFO incident and the captured EBE (extraterrestrial biological entity). Its primary purpose became to decipher aliens' communications and language and establish a dialogue with them. The code name for this project was SIGMA. This was then extended to include monitoring worldwide communication systems related to the subject of UFOs to establish complete control over the secrecy of the alien presence. (As we shall see this had nothing to do with scaring the public but to conduct dubious negotiations to obtain superior military technologies.)

Later MJ-12 became known alternatively as the Majority Agency for joint intelligence, MAJI or MAJIC ('C' for control). The formation of the MJ-12 was particularly prompted by the Roswell incident in 1947. A spacecraft was apparently brought down by the magnetic radiation from radar experiments conducted by the

military. It wasn't realised that the radar could be used as a weapon in this manner. According to channelled information¹ these aliens were from Sirius but had some similar traits to the Zetas. A second crash shortly after this was also of a spacecraft from Sirius but the beings were more human looking, though small in stature—around 3-4 feet. In 1948 there was reported to be a crashed disk in New Mexico in which were found human body parts. It was apparently a medical ship possessing a medical laboratory, and reportedly it was not unusual to find such things. The ship had a self-destruct mechanism, but apparently had failed to destroy the human parts. The EBE that was caught by the government following one of the crashes around 1947-48 was confined and died in 1952.

Following these incidents, a great deal of attention was given to the UFO problem; in particular to understand space-craft technology; what has now become known as reverse engineering. The NSA (National Security Agency) was created to protect the secret of any alien encounter; it became automatically exempt from all laws. The various departments: CIA, OSI (Office of Scientific Intelligence), ONR (Office of Naval Research), R&DP (the Research and Development Board), and the NSA Scientific Intelligence, only received limited information from MJ-12; none knew the whole story. Through the NSA all forms of communication could be tapped and monitored.²

This Agency carries the greatest secrecy over any other security issues in covert governmental operations and it not only took command over crashed UFOs but provided a team to liaise with the extraterrestrials, mainly the reptilian Drakonians and the Zeta, which were usually the 'little Greys' (a different hybrid). In 1953 many spacecrafts were observed by astronauts, in particular, a group of large ships that took up position in orbit around Earth, but with unknown intent. Shortly after this, a second more humanoid group landed at an Air Force base in Florida, who warned the Government of the race in orbit and offered to help the Government with Earth's spiritual development, but which involved demands, such as dismantling all nuclear weapons as a condition. The offer was rejected.

According to William Cooper, former United States Naval Intelligence briefing team member, and described as the world's expert on UFOs in his day, between 1947 and 1952 there were at

least sixteen crashed or downed UFOs, with sixty-five dead aliens and one captured alive. Thirteen of these occurred in the United States. Further, by 1953 when Eisenhower was president, at least ten more crashed spacecrafts were recovered with twenty-six bodies; four alive. Cooper explains that Eisenhower confided in Nelson Rockefeller for assistance with the alien problem, which was a big mistake, but was the result of the Rockefellers' influence in backing Eisenhower for presidency. As a consequence, Nelson Rockefeller was appointed chairman of a Presidential Advisory Committee on Government organisation, which meant he was now responsible for planning the re-organisation of the government.

Although the aliens had made their presence known years before the formation of MJ-12, it nevertheless was a massive shock to the president and selected government personnel when they were confronted with a 'downed' alien craft and crew. The first crashed UFO in the Mexico desert was reported to have been manned by insect-like beings. However, a huge variety unfolded since that time. These particular EBEs would probably be a hybrid of the little Greys. Nevertheless the Dracos-Zeta hybrid had the reputation of being the most hostile of the Zeta hybrids. Amongst these countless varieties there were, Zetas, Zephelium*, Dracos-Zeta, Rutilia, Reticuli, Rigelians, and reptilian and insectoid hybrid types. [*The original Zeta race possessing more human-like characteristics.]³

Eisenhower met with the aliens in January 1954. For most of the uninitiated humans that were present, their experience was a stunning shock to their normal secure reality, and their Earthly world would never appear the same. The science fiction and speculation about other worlds was forever removed from their consciousness.

Nevertheless, a treaty was formed. The Treaty decreed that the United States and the aliens would not interfere in one another's affairs and that the presence of the visitors would be kept a secret; also that the aliens would not make a treaty with any other Earth nation. All abductions would be reported and no one harmed, and that memory of the abductions would be erased. The Government clearly turned a blind eye to animal mutilation experiments.

It is a simple deduction as to why the aliens would want their presence unknown to the public, since as described in Chapter 5 the less the people knew of the human exploitation that was occurring the easier it would be. In fact, if the average person who even accepts the occurrence of abductions knew of the high percentage of the population that have been abducted to this day, they would never believe it.

Underground bases were constructed for the aliens where technology deals were conducted. Any alien technologies were archaic from the visitor's point of view but very advanced for the government. One base was a top-secret facility, which has become the notorious Area 51. Further refinements to security resulted in a project named Snowbird in which crafts were specially built to debunk true UFO sightings, and such Snowbird crafts were even demonstrated to the press. It was very successful in reducing UFO reports.

It is not surprising that many government agencies have no notion of these programmes and are easily fooled into believing it is all a hoax. Moreover, debunking tactics—and this tends to be overlooked—included falsely planted hoaxes to further reinforce the cover-up. There are many cases of debunking of MJ-12, through exposure of false documentation. For example, the FBI was prompted to investigate the authenticity of such documents, but in failing to recognise the level of secrecy, they had questioned the United States Air Force regarding the tenability of the MJ-12 agency and were informed that no such committee had ever been formed. Even presidents, who were cognizant of military extraterrestrial and UFO information, since the formation of MJ-12, were and are given information on a need-to-know basis and often given false data. The FBI concluded that the existence of MJ-12 was completely bogus.

Inevitably there were dangers for anyone involved in such security, in particular when they had conflicting ethics about what should and shouldn't be concealed from the public. Recall what happened to the Secretary of Defence, James Forrestal, who opposed the secrecy and considered that the public should be informed what was going on. His resignation was requested by the president. It was later reported that he had a mental breakdown and was hospitalised but when his brother announced he would release James, the CIA intervened. After entering the

hospital they tied one end of a bed sheet around Forrester's neck and the other to a support and threw him out of the window. His death of course was certified as suicide.

Clearly the full reasons for the 'necessary' secrecy wasn't 'public panic' but much more nefarious reasons, such as exchange of alien technology for allowing the aliens covert and forced exploitation of humans regarding genetic studies and DNA material. However, the government were deceived into thinking this was the entirety of their intentions, whereas the alien agendas for the planet were much more extensive and detrimental to humanity (see Chapter 5).

To protect the extreme secrecy and keep the alien problem out of the normal government awareness and the press, the Bilderberg Group was formed by 1952, which evolved into a secret world government.⁴ A fastidious level of security was established with reducing concern and increasing confidence regarding leaks, and meetings with the alien visitors became more numerous. But did they all go smoothly?

Let us digress at this point to relate a horrifying alien interaction, described by Dr Michael Wolf in his book, who was a research scientist for the Secret Government and a member of the MJ-12.⁵

This event, coming from such a qualified and reputable scientist, is probably one of the most convincing single verifications of the existence of the MJ-12 for those not prepared to conduct extensive research. His book is quite a revelation, but as a result of what he disclosed, after retirement, he was assassinated as we shall see shortly (but it took more than one attempt and he finally died of an inflicted terminal illness).

Dr Wolf had exceptional academic qualifications: Ph.D. in quantum physics, Ph.D. in computer science, medical and genetics degrees and he was a surgeon and pilot. He was interviewed by Dr Boyle (doctorates in physics and psychology) who commented to this author that Michael Wolf was a remarkable man.

In addition to his brilliant academic qualifications, Dr Wolf served as consultant to the President and the National Security Council on ET matters, was the UFO secrecy management agency's Special Studies Group and, as stated, was a member of the Majestic Twelve (MJ-12). He had worked on many secret government projects and had been a prominent participator in the
